### TOWN BOARD MEETING 02-10-2025

**CALL TO ORDER:** The meeting of the Town of Eaton was called to order by Chairman Rick Christel at 6:30 p.m., Monday, 02-10-2025 at the Eaton Town Hall. The Pledge Allegiance to the flag was recited by all.

**MEETING NOTICES:** Meeting notices were posted at the Eaton Town Hall, and the Town Website timely.

**ROLL CALL:** Rick Christel, Chairman; Joe Riesterer, Supervisor, Lewy Schema, Supervisor, Paulette Vogt, Clerk, Pam Schneider, Treasurer, and Ben Schema, Town Constable, were in attendance along with Randy Knier and Road Superintendent Craig Zipperer.

**AGENDA:** The agenda had been emailed previously. Supervisor Schema made a motion to accept the agenda, and Supervisor Riesterer 2<sup>nd</sup> the same, motion carried unanimously.

**MINUTES:** The minutes from the 1-13-2025 meeting had been emailed to the Board previously. Supervisor Schema made a motion to accept the minutes. Supervisor Riesterer 2<sup>nd</sup> the motion. Motion carried unanimously.

**PUBLIC INPUT:** A Town resident had some questions about rezoning some property they owned. With no other public input, Chairman Christel closed public input.

**ROAD SUPERINTENDENT:** Road Superintendent Craig Zipperer reported on the many jobs he has been doing this month. Craig stated that all glass for recycling does not have to be separated according to color from now on.

**TREASURER'S REPORT:** The treasurer's report had been emailed to the Board previously. A motion was made by Supervisor Schema to accept the treasurer's report and Supervisor Riesterer 2<sup>nd</sup> the same. Motion carried unanimously.

**CONSTABLE:** Constable Ben Schema reported that he did not have any calls for the month.

**ASSESSOR:** No report.

### TOWN BUSINESS:

**BERTRAM BROADBAND ENDORSEMENT:** After some discussion, Supervisor Schema made a motion to Support the Endorsement of Bertram Communication LLC's Application for BEAD Funding. Chairman Christel 2<sup>nd</sup> the same. Motion carried unanimously. Chairman Christel will take care of the correspondence that states this support.

**ACCEPTANCE OF CLERK'S LETTER OF RETIREMENT:** After some discussion, a motion was made by Chairman Christel and 2<sup>nd</sup> by Supervisor Riesterer to accept the Clerk's letter of retirement. Motion carried with 2 yes's and 1 no.

REVIEW ANNUAL REPORT BOOKLET: The annual booklet was reviewed and will be updated with a few minor changes as noted, prior to the annual meeting.

APPROVE VOUCHERS: After reviewing the bills and signing the same, a motion was made by Supervisor Schema and 2<sup>nd</sup> by Supervisor Riesterer to approve the vouchers. Motion carried unanimously.

MEETING REPORTS: Chairman Christel reported on the WTA – Manitowoc County Meeting that he attended.

CHAIRMAN UPDATES: Chairman Christel received an email from the lawyer about the dead end road matter that the lawyer has been working on.

Chairman Christel also reported that he received the contract from the Collins Fire Department that will be put on next month's agenda.

CLERK'S REPORT: The Clerk reported she is preparing for an election for February 18, 2025, and another election for April 1, 2025.

There being no further discussion, Supervisor Schema made a motion to adjourn the meeting. Supervisor Riesterer 2<sup>nd</sup> the same. Motion carried unanimously.
